Methods for Cleaning Up: Absorb onto an inert, absorbent substrate and sweep up. Wash area with soap and water to prevent slip/fall hazard.

Handling

Safe Handling: Keep away from sources of ignition and open flames.

Storage

Store in shade, in fresh place to prevent oxidation. Maintain containers and close basins and as much as possible with nitrogen atmosphere for its conservation. Plastic and metallic container recommended. The metallic drums must be covered with interior coating in order to avoid direct contact with iron, catalytic of the oxidation.
